
**Re-Admission for Unsuccessful Students (HS Final Examination, 2026)**

ASSEB/DIV-II/R&A/PORT-NOTF/2026/53/2334, dated 28.04.2026, it is hereby notified to all concerned that the "SUJOG" the re-admission portal will be made live from 11<sup>th</sup> May, 2026 in order to facilitate the re-admission of the unsuccessful students of H. S. Final Examinations to the H.S. Second Year Class for the academic session 2026-27 in various institutions (Universities/Degree Colleges/Senior Secondary Schools/Higher Secondary Schools) under ASSEB, DIV-II, for updating institutional profile.

Accordingly, all affiliated institutions are hereby directed to visit the official website: <https://ahsec.assam.gov.in> and update their institution profiles using their existing DARPAN login credential from 11/05/2026 to 14/05/2026.

Thereafter, eligible students will be able to submit their applications online from 15/05/2026 to 24/05/2026 for re-admission to H.S. Second Year Class in different institutions through the "SUJOG" re-admission portal. All concerned institutions and students are advised to go through the prescribed guidelines/SOPs, important dates in detail for compliance and smooth conduct of the re-admission process.

**GUIDELINES/SOP FOR INSTITUTIONS:**

SL. NO.	GUIDELINES/SOP FOR INSTITUTIONS
1.	After verification of applications, the Selection List and Waiting List for re-admission into H.S. Second Year will be prepared by the institutions concerned.
2.	Selection List and Waiting List for re-admission will be made available on the re-admission portal "SUJOG" for the students. Moreover, students will also receive notification of their selection through SMS.
3.	The Institutions are to ensure that physical verification of documents shall be conducted at the time of re-admissions into H.S. Second Year Class.
4.	Once a selected student accepts the re-admission offered by the institutions, the institutions will have to click the "Confirm Re-admission" button to complete the re-admission process in the portal using Institution Login ID on daily basis during re-admission process latest by 30/05/2026. The institution will be able to confirm re-admission of only those students who have accepted the Re-admission Offer.
5.	The institutions will be able to change the preferred Subject(s)/Stream of a student at the time of re-admission as per the provision available in the portal and with due consent from the student and the institution concerned will have to update the same in the portal on the day of re-admission. Moreover, change/modifications in the stream and Subject(s) of the students will be available on the re-admission portal "SUJOG" even after the re-admission process is over, for a duration as stipulated by ASSEB, DIV-II in due course.
6.	Institutions should refrain from getting students admitted without his/her consent.
7.	Issuance of Gap permission certificate from ASSEB, DIV-II for re-admission into H.S. Second Year Class has been discontinued. Hence, such students who are seeking re-admission after a gap period will be admitted by the institution concerned after proper verification of documents, reasons of gap and eligibility. Such cases should not be referred to ASSEB, DIV-II.

**GUIDELINES/SOP FOR STUDENTS:**

SL. NO.	INSTRUCTION FOR STUDENTS
1.	A Student has to submit application online through "SUJOG" re-admission portal.
2.	A student can apply up to maximum of three (3) nos. of applications.
3.	To edit profile of a student, he/she can visit the PROFILE TAB in the student dashboard before preparation of selection list by the institution. The profile of a student can be edited only once.
4.	The published Selection List and Waiting List for re-admission into H.S. Second Year will be made available on the re-admission portal "SUJOG" for the students. The students will be notified of their selection through SMS.
5.	After publication of selection list, students will be allowed to approve only one institution for re-admission using their login id in the portal. The student must take re-admission in the institution concerned within the stipulated time period to complete the re-admission process.
6.	A student will be able to change their preferred Stream/Subject(s) at the time of re-admission. Students will be able to change their preferred Stream/Subject(s) at the time of re-admission as per the provision available in the portal and the institution concerned will have to update the same in the portal on the day of re-admission.
7.	If a student does not accept the re-admission offer within stipulated time, the student will be removed from Selection List with information through SMS.
8.	If a student does not apply/select any institution within stipulated time of opening of "SUJOG" re-admission portal, the student's name/profile will be disabled on the portal with information through SMS.
9.	Mobile number should be unique for registration of student on "SUJOG" re-admission portal. Same mobile cannot be used for multiple applications.
10.	Issuance of Gap permission certificate from ASSEB, DIV-II, for re-admission into H.S. Second Year Class has been discontinued. Students are advised to consult with institutions for their eligibility for re-admission.

- NB: 1. Re-admission of the students whose marksheet are marked as 'Compartmental' is not required.  
2. The re-admitted students will attend class from 02/06/2026.
